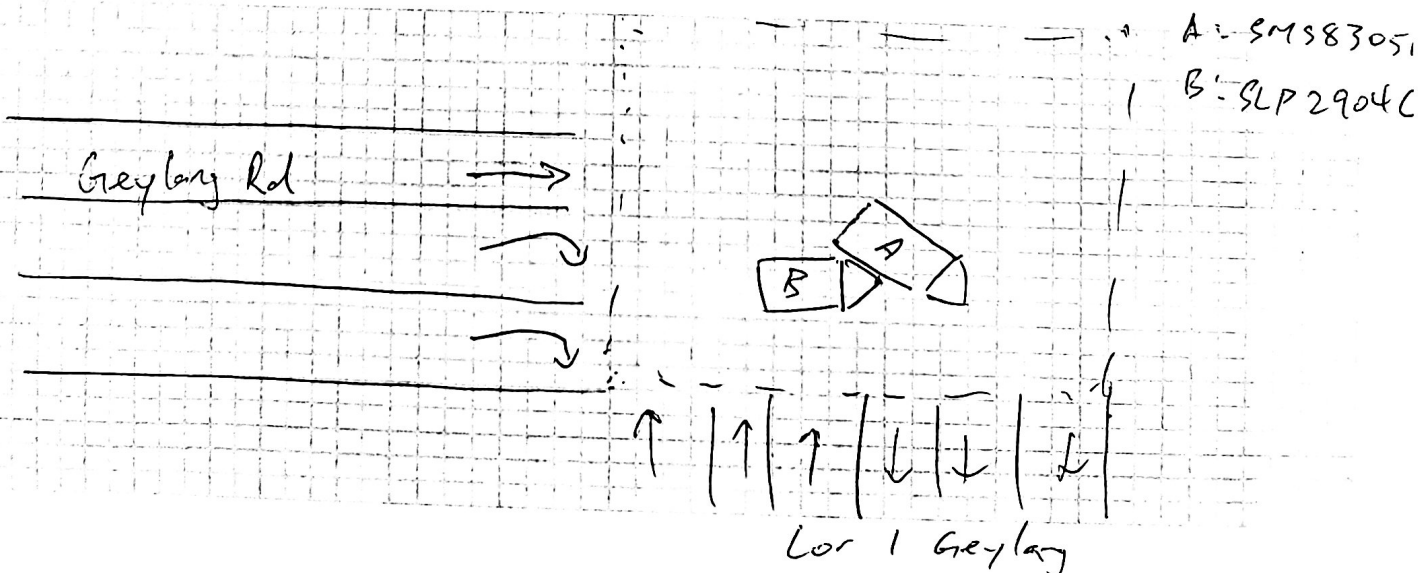

Sketch Plan







