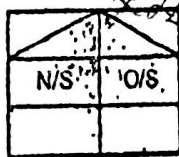

carpark.


As soon as the van turned in, I slowly move my car forward

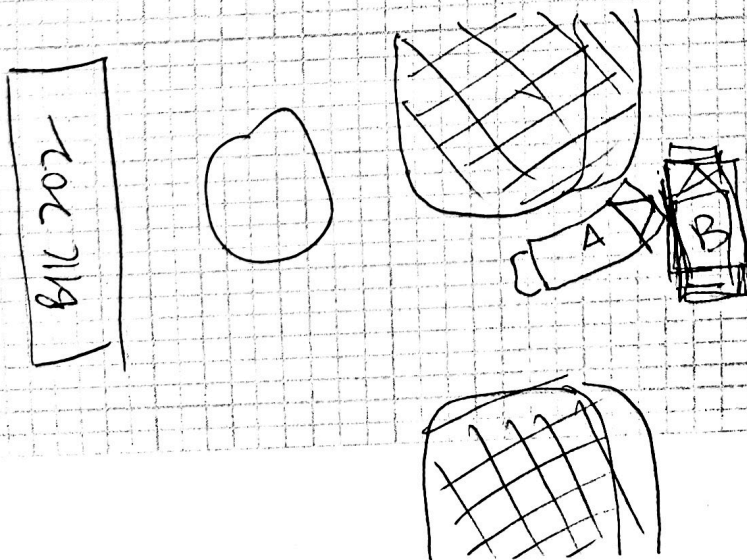
