Brief Details.

On 27/10/20 at about 2115hrs I was riding my motorcycle (JSG5763) along Alexandra Road towards City on the extreme left lane (3 lane road). While I was at the entrance of Alexandra Hospital entrance, at the yellow box, on the move when a Comfort Taxi (SHB4759M) made a sudden right turn from the opposite direction and collided onto the left side of my motorcycle. I was thrown off my motorcycle and landed on the road. I was still conscious at that point of time.

The taxi driver then stopped his taxi and came down to check on me. Ambulance was called in and I was conveyed to NUH for immediate treatment. I was warded there for about 3 weeks before they transferred me to Jurong Community Hospital for rehabilitation. I suffered fractures on both my foot, my right knee and my left shoulder.

I was given 30 days of medical leave after I was discharged from hospital. As I was warded for a long period I could not make a traffic accident report earlier. I also received 63 days of hespitalization
