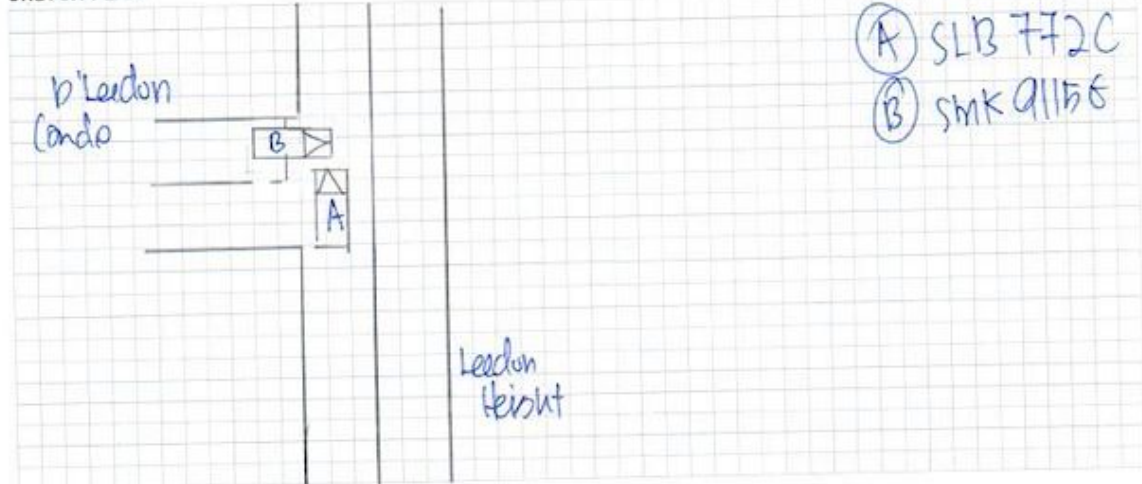

SKETCH PLAN

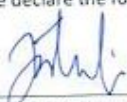


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

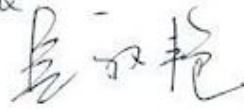




My vehicle SMK 9115G drove out from D'Leedon
