





ACCIDENT INVOLVING SML 6243J(AIG) AND SKB 566T AT/ALONG TAMPINES AVE 2 ON 12/02/2021

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third party claim against your policy.

We have received a claim from SKB566T against your insurance policy.

Based on both parties report and all the available information on hand, we are of the view that liability is not in your favour as your driver changed lane and collided with third party who was driving straight within the lane. Under Motor Accident Guide, vehicle should keep in the proper lane and change lane only when it is safe. Therefore, we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
