Brief Details.

It was a 2-way lane where one lane was turning left and the right most lane was going straight or making a u-turn. While I was travelling in the right most lane towards bukit timah road. The taxi driver made a sharp turn as there was a taxi infront of him. He made the turn without checking his blind spot jumping from the taxi lane into the right most lane. As I was travelling straight in the right most lane, I honked at the taxi driver signaling him that I am in the right most lane, However, he did not heed to my horn and advanced forward cutting across the lanes. I was side-swept towards the kerb and I hit into the Taxi's right side. I was conveyed to hospital via ambulance. The accident took place near the taxi stand behind tekka centre, I only have the post-accident images.
