SKETCH PLAN

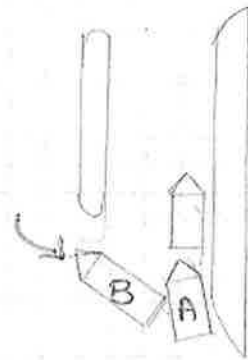
