Brief Details.

On 12/02/2021 at around 1530hrs, after I made a delivery to 91 Tanglin Halt Road, I was riding my motorcycle along Tanglin Halt Road towards the T-junction to Commonwealth Dr, to turn into Queensway. As I was riding along Tanglin Halt Road, on the right lane, there was a gold Mercedes car on my left lane, diagonal to my left. The car suddenly made a turn to the right into the carpark of blk 34 Tanglin Halt Road and hit onto me as I was travelling straight and couldn't react in time. I flung to my right and landed on the green barrier and subsequently landed on the walking pavement.

The driver of the car, stopped. However she continued to park the car first, make a call to someone and then subsequently alighted to attend to me. While she is making a call, a witness came over to assist me. The witness gave me his name card to offer himself as a witness. The driver is a female Chinese in her 50s. She said that she will be responsible of the accident and told me to give her "chance" and not to inform the Police that she is using the phone while driving. She gave me her handphone number (96643697) and offered to settle this matter by private settlement.

The witness called ambulance and Police, and both attended the scene.

I was conveyed to National University Hospital, and the doctor informed that my left ankle suffers multiple abrasion, ligament tear and needs to go for operation on the day itself.

I was discharge on 14/02/2021 and was given 16 days of Medical Certificate (Cert no. NUH21040583) by AARON HO KWUN HANG (P2249A).

I tried calling the driver using the given number multiple times but to no avail.

I was advised by the Police who attended my incident to lodge a Traffic Police report.
