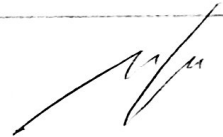

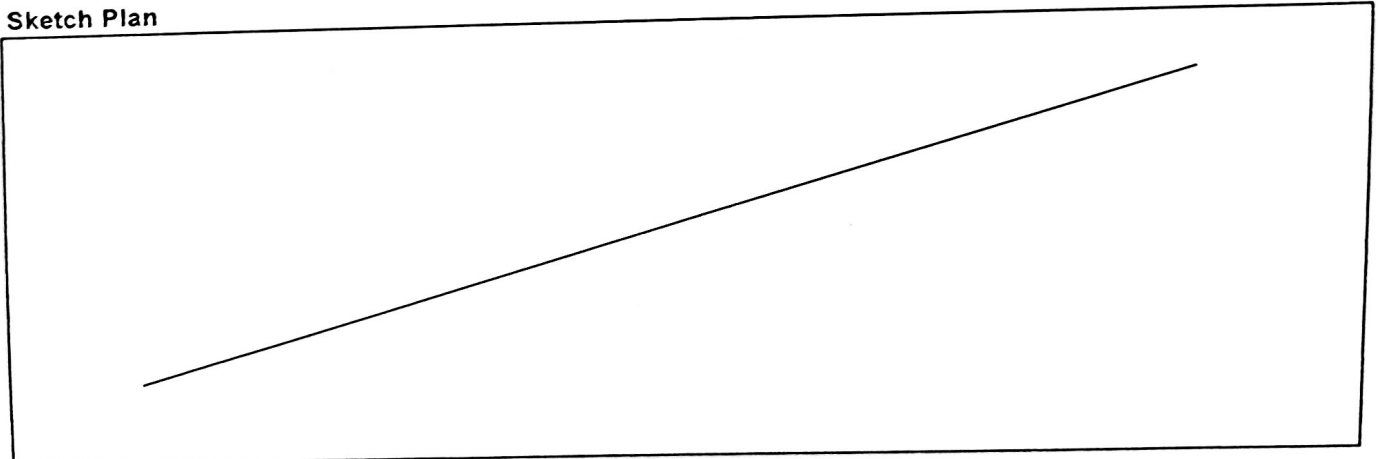

Sketch Plan



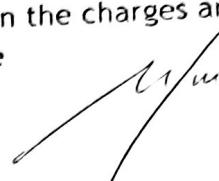
Describe Circumstances of the Accident

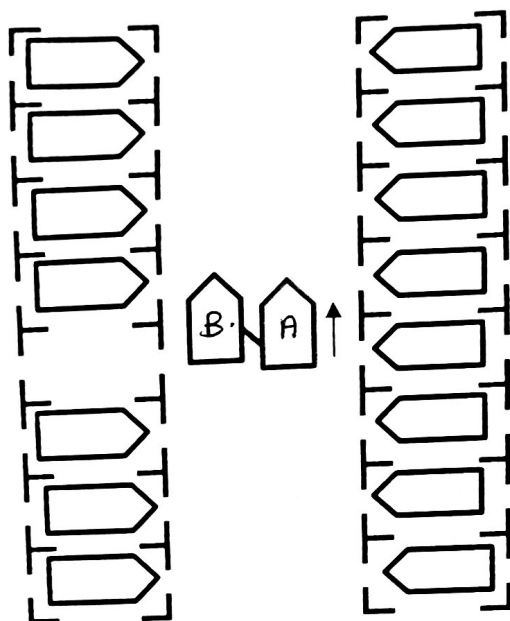
After the accident, we alighted from our vehicles to take photos and exchange particulars. Driver of vehicle B apologized for causing the damage.
