Brief Details.

On the 21/12/2020 at 1800hrs, I was riding my motorbike bearing registration number FBN92L along Frankel Avenue towards East Coast Road. I noticed that there was a car bearing registration number SJB5349H on the incoming side of the road. All of a sudden, the car abruptly turn right to go to Esso petrol station. The car was near in front of me that I was forced to swerve my motorbike to the right to avoid the collision. I fell towards my right side. I wish to state that I did not collide with the said car. The driver of the car did not stop the vehicle and proceeded to Esso petrol station.

I had bring my motorbike up myself and walked towards the driver. The driver did not rendered assistance to me and she denied that she was the one who caused me to evade from colliding onto her car while she made the abrupt right lane turn into the petrol kiosk. We both exchanged particulars, the driver left the place. I noticed that I had abrasion onto my left knee. I discovered that there was scratches onto the right side of my covers set, misalignment to my handle bar and the side right side indicator was damaged. I went to Changi General Hospital to make a check and I was given 3 days of medical leave. I wish to state that during the incident, no government property was damaged.
