





Brief Details.

On the 25.02.2021 at about 9.30am, I had parked my vehicle bearing registration number EA2318G, an Audi A4 (Dark Grey in colour) at the open carpark of Blk 202 Jurong East St 21. I could not remember the carpark lot number. On the same day at about 6pm, I went to retrieve my vehicle and discovered that the front right bumper of my vehicle was damaged and slightly detached from my vehicle. I then checked on my In car camera and discovered that on the same day at about 2.24pm, one black in colour van parked beside my vehicle on the right was moving out from the carpark lot. The black van was moving out from his lot and turning left. As a result, it collided onto my vehicle. In the video, I spotted one male subject wearing cap seated at the front passenger seat. However the video did not capture the black van registration plate number and their further actions as the video recording only lasted for few seconds. There was no note left behind. I am making this record to claim insurance.
