We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from PC8125R against your insurance policy.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by PC8125R. From the video footage submitted by PC8125R, we observe that third party was driving straight within his lane while vehicle was turning out from slip road as resulted the collision. Under Motor Accident Guide, vehicle approaching the major road from a minor road should stop at the stop line or parallel broken white lines to give way to oncoming traffic on the major road. Therefore, we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
