We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third party claim against your policy.

We have received a claim from SMG9590M against your insurance policy.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by SMG9590M. Your vehicle filtered to the left lane and collided with third party. Under Motor Accident Guide, vehicles should keep in the proper lane and change lane only when it is safe.
