1. Front RHS Side Signal Lamp – cracked, resulting in water seepage.
2. Front Bumper Towing Cover – parts were missing, hence unable to service.
3. Front Bumper Number Plate Garnish (SN) – plastic parts were cut and cracked, hence cannot be serviced.
4. The application of anti rust chemicals is necessary to be applied on repaired areas to be protected from rust.

We attach herewith pictures supporting the above.

Kindly revert with your clarification / amended report.

On a separate note, we note that the date of the SJE report is 25th March 2020. Kindly clarify if it should be 25th March 2021.
