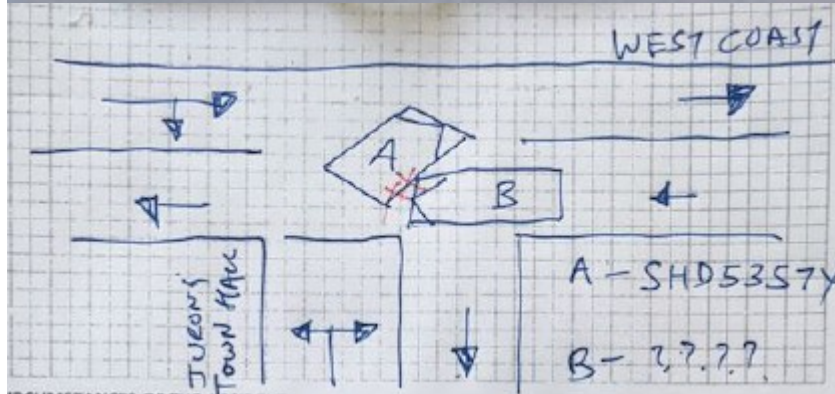

We regret to inform that we do not have video or photo for this case.

However we enclosed driver statement for your investigation.

		Degree of Injury	Slight
Brief Details. On the above mentioned date and time, I, Hai Huat, bearing NRIC of S0728456Z, was driving my taxi Toyota(SHD5357Y) with one passenger on board along Jurong Town Hall Road. As I was about to turn for the right to West Coast Road while it was appearing green on the traffic light, I noticed that there was a lorry(unknown number plate) heading towards me. I didn't managed to press the brake on time, subsequently my vehicle inched forward and the lorry collided with my vehicle causing damage do the rear back door on the right side. I sustained minor injury on my left shoulder after the collision. Afterwards I came out of my vehicle and went over to the back to check with the passenger. I also went over to the vehicle to exchange particulars but he refused to come out. At about 1400hrs subsequently Traffic Police and ambulance came to the scene. The TP officer then instructed myself and the other driver to drive to the side of the road. He also informed he will be taking my vehicle Video Camera SD card and issued me with an acknowledgement slip. Paramedics then attended to me and conveyed myself alone to Ng Teng Fong General Hospital. I wasn't informed about my vehicle whether it was being towed or not. I would also like to inform that I wasn't aware if there is any camera around the vicinity.

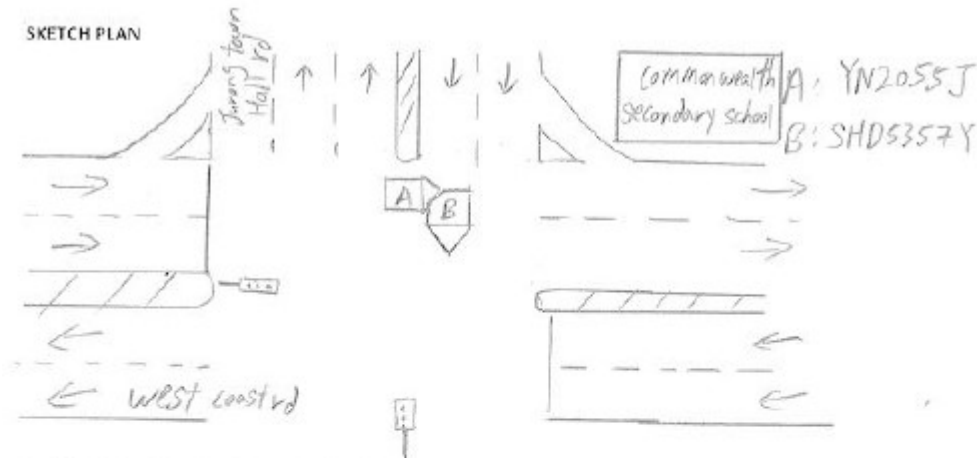
