#### CIRCUMSTANCES OF ACCIDENT

I was driving on CTE exiting to PIE Changi at about 2.25pm 8th March 2021. The traffic was clear and I was driving behind the van PA7882E with a safe distance. Without warning the van jam braked twice resulting in a collision between me and the van. The first brake did not cause an accident as I managed to brake in time. The second jam brake few seconds after the first caused me to rear-end the van. The van drove forward slightly before the van drivers exited from the vehicle. After making sure that no one was injured in my vehicle I exited the car and communicated with the van drivers. After taking some photos two unknown men appeared from the side and told us and the van drivers to move away from the highway and exchange particulars. On reviewing my rear dashcam I noticed that one of the men seemed to have taken a photo of my vehicle despite not being the driver or passenger. I went back to the vehicle to obtain my driving license and the van started driving off first. I decided to follow them to exchange our details thinking that they might stop along the side of the road. However the van drove off without stopping. It went one round and reentered the highway and subsequently disappeared.
