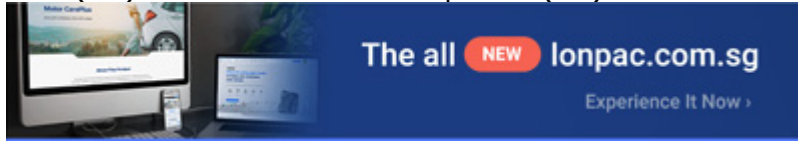

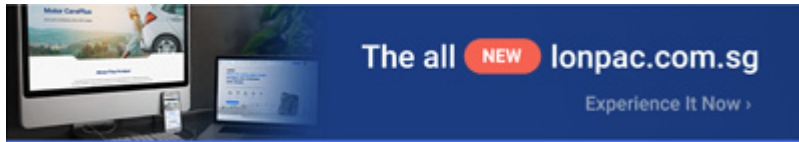

In addition, the third party vehicle should be SHA4041P and not SHD4041F.

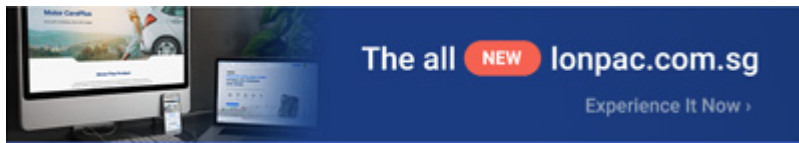
