

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Accident happened around 1029hrs at 181 River Valley Rd ITSO (LTABldg) carpark. 1 LTA staff went up to my control room to inform 2 bikes had been knocked down by an LTA car (SMT 1149P). My bike FBK 8520H and my colleague bike FBK 65009. Both bikes were stationary (parked). At the carpark both bikes were not at the original position. The driver Ms Hu Kai Lin informed she had knocked the bikes while attempting to reverse and parked the car. She informed after knocking the bikes, she put the bikes up back and parked the car. She had made report and video footage from the car was handed over to the report centre. She admitted she had knocked the bikes. Few damages to my bike: My left hand side coverset, broken bottle holder, damaged crash bar and engine cover.


