


Dear Li Li,

We refer to the above matter and as discussed earlier.

TP reported that he was travelling straight along Upper Bukit Timah Road towards Tampines at extreme left lane, suddenly our insured vehicle trying to overtake his bus and side swipe to his right front portion.



OI reported that TP was moving out from bus bay and collided to his vehicle while he passing by the bus stop.



We have requested TP to provide evidence for our further consideration. However, TP unable to provide any evidences.

Based on damages sustained to both vehicles, we are of the opinion that at the time of the collision TP vehicle was slanting position. TP bus sustained damages onto right front corner and our insured vehicle sustained long grazed marks along its left side body, it's subjected that one vehicle is slanting position at the time of the collision. If both vehicles side swipe as alleged by Third Party, his bus should not be sustained damage on its right front portion corner only but also should have damages on its right side body.

Therefore, our insured version is more probable and we are intending to reject Third Party claim.
