We refer to our letters of 10/03/2021 and 1st reminder letter dated 28/04/2021 requesting for your reporting of the above accident.

We have checked our records and we are unable to trace your reporting of the accident to our office. Please note that with the effect of 1st Jun 2008, under the Motor Claims Framework (MCF), you are required to report any accident at our Premium Workshops or reporting centres (if applicable) with your accident vehicle (whether damage or not) within 24 hours or by the next working day of the occurrence of the accident. Any non-compliance of this condition will result in a loss of your No Claim Discount upon renewal of your policy and your claim will be prejudiced. The primary purpose of this reporting is to provide your version of the accident and does not automatically render you liable for the accident.

Please take note that we shall inform the **Traffic Police** of the non-reporting if we do not hear from you then.

Furthermore, the owner of vehicle SKX 4278H has submitted a claim against you and we are unable to revert on their claim as a result of your non-reporting of the above accident. If we fail to hear from you by **30/05/2020**, we shall assume that indemnification under the Policy is not sought, and we shall refer the third party claim to you for direct handling.
