

## Brief Details.

On 26/02/2021 at about 0045hrs, I was riding my motorbike with vehicle no . JNF 7614 from Anchorvale Lane towards Hougang. While I was riding my motorbike along the junction and going straight, suddenly there was a Comfortdelgro taxi with vehicle no. SHA 2204R come from the opposite and wanted to turn right into junction. As such, the taxi hit onto the right side of my motorbike which caused me to flunk infront towards the left. I am conscious at that point of time. The taxi driver approached me and asked whether I am okay. I did not managed to get his particulars.

Subsequently, Ambulance and Traffic Police came down to the accident location. Traffic Police advised me to lodge a traffic police accident report after discharged. I suffered from fracture on the left toe and femur shaft and open wound on the heel. Ambulance then conveyed me to Khoo Teck Puat Hospital and was hospitalized for 10 days and was given hospitalization leave for 42 days from 26/02/2021 to 08/04/2021. I am not sure the damages of my motorbike as it is still being towed away.
