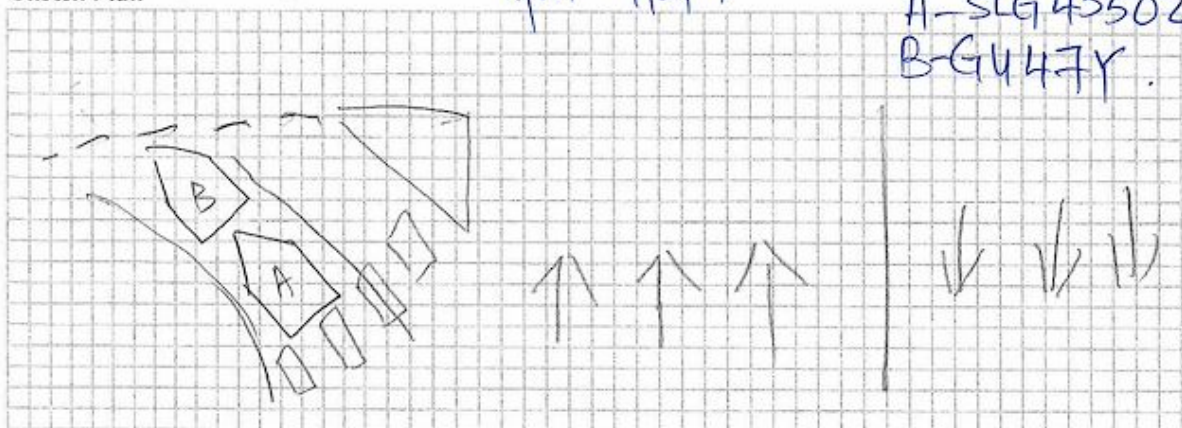

Describe Circumstances of the Accident


Driving from Paya Lebar Road to PIE before filter out. While checking on coming car, I accidentally knock on it.


