We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from GBJ5646C against your insurance policy.

Based on the accident report and accident scenario, we are of the view that liability is not in your favour your vehicle moving out from the parking lot and collided with third party who was moving straight ahead on the driveway.
