**SKETCH PLAN**



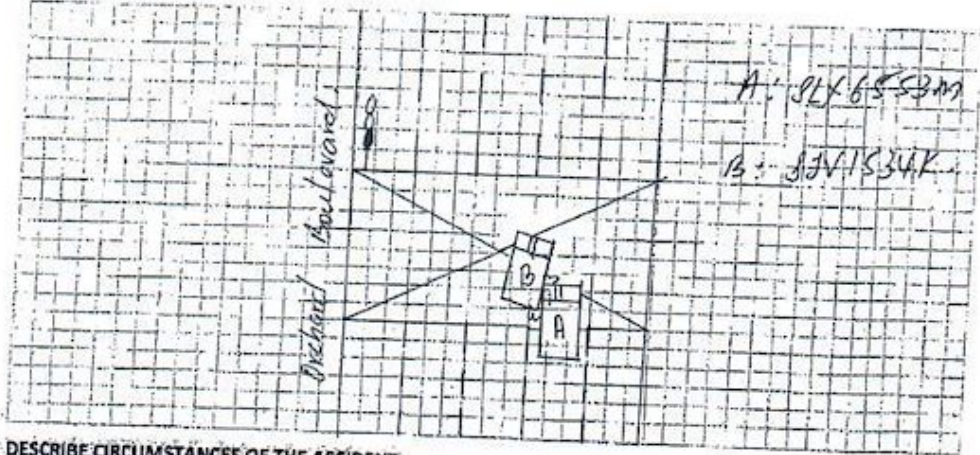

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
