Title: accident junction turning into BKE from mandai road

I was exiting the night safari and was travelling along mandai road to enter BKE to get towards serangoon north ave 4.

About 30-50meters before the junction for turning into BKE, there was a traffic light along mandai road and the traffic light was red and there was a car in front of me and I was queuing behind the car.

We then proceeded to the junction for turning into BKE. It was a 2 turning lane junction, however I kept to being behind the vehicle in front of me on the right most lane instead of taking the empty lane beside it.

The traffic light was green in our favor to proceed with the turn towards BKE, the vehicle ahead of me proceeded to turn, and I then checked to see that there was no oncoming vehicle and likewise I proceeded to make the turn.

As we were towards the end of the turn, we suddenly heard a screeching sound and the bright headlights of an oncoming vehicle (SMP 8482B) that is coming towards us at a very high speed. This vehicle was nowhere in sight when we were making the turn. It was around 11.40-11.50pm at the time and there were very few vehicles. Tho we tried our best to avoid a collision, he hit the left back of our vehicle (position behind the petrol tank outlet).

We then proceeded to stop the vehicle at the side of the road (which is at the entrance of BKE) and when we look backed, we noticed that he drove away.

As we were at the entrance of the expressway and there was no way to turn back and identify the vehicle, we decided to proceed on with our journey and to make a report the following day.

However after driving off, vehicle SMP 8482B sped up and identified himself as the vehicle that had knocked into us earlier. We then proceeded to exchange details and pictures of the damage.
