

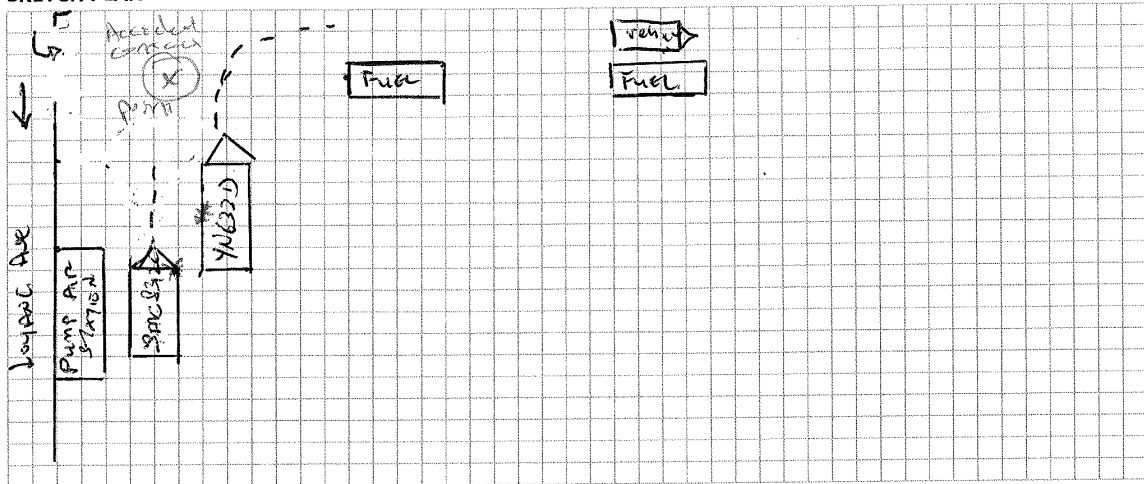

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 12/08/20 @ 0930hr, after finishing refuelling the lorry petrol, I reversed my lorry (see above) as being obstructed my front vehicle. I waited for on coming vehicle to clear (vehicle entered from entry at Loyang Avenue) after which, I moved my lorry forward. 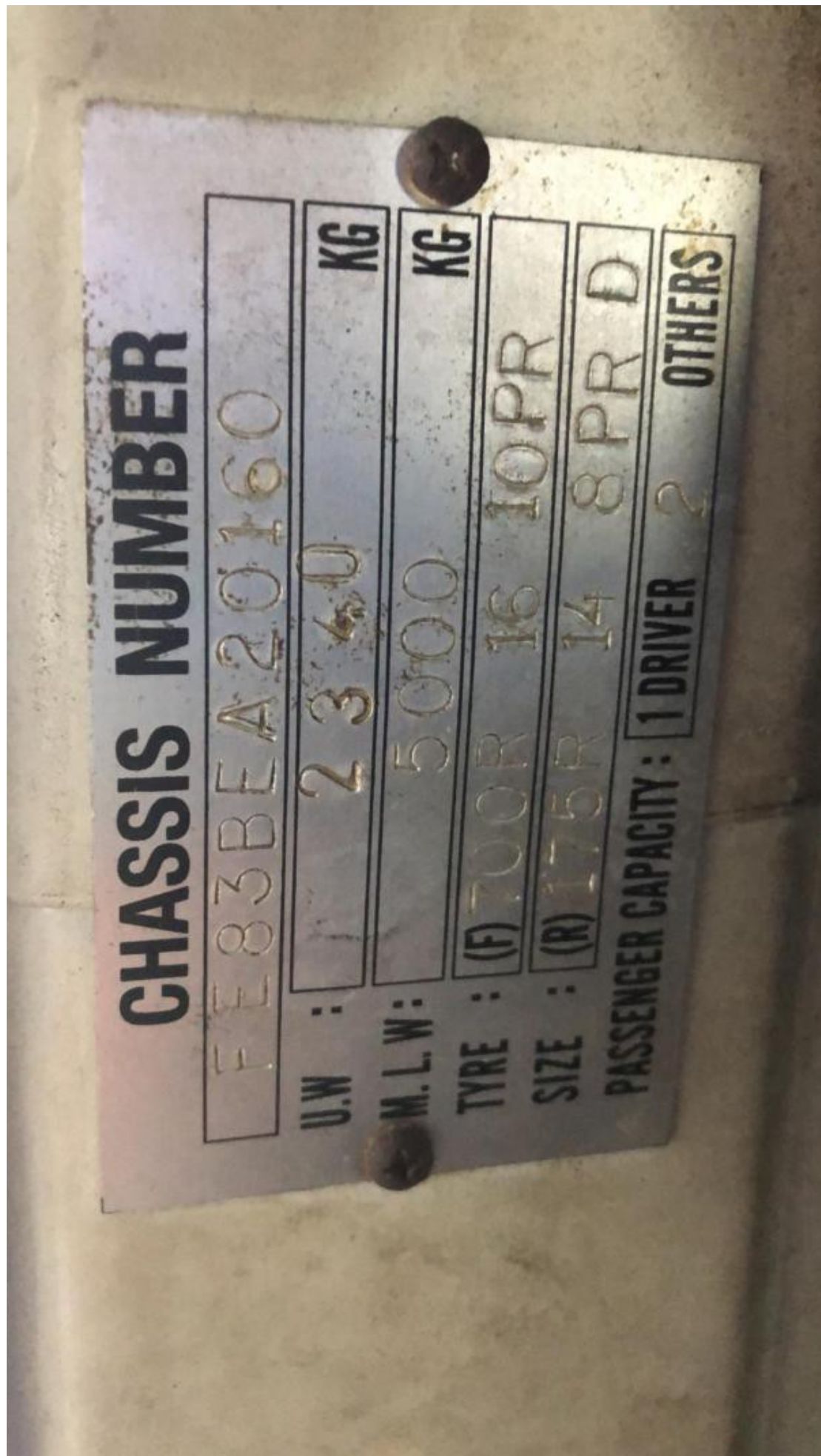
