At around 5.45pm, I returned back to the MSCP and discovered a blue Hyundai taxi (Comfort Delgro), SHC3540C had hit onto the carpark barrier, the carpark wall, my motorcycle and 2 other Singapore motorcycle.

I spoke to the taxi driver a male Chinese about 50-60 years old, who informed that there was something wrong with his taxi. His taxi suddenly accelerated and he could not brake his taxi.
