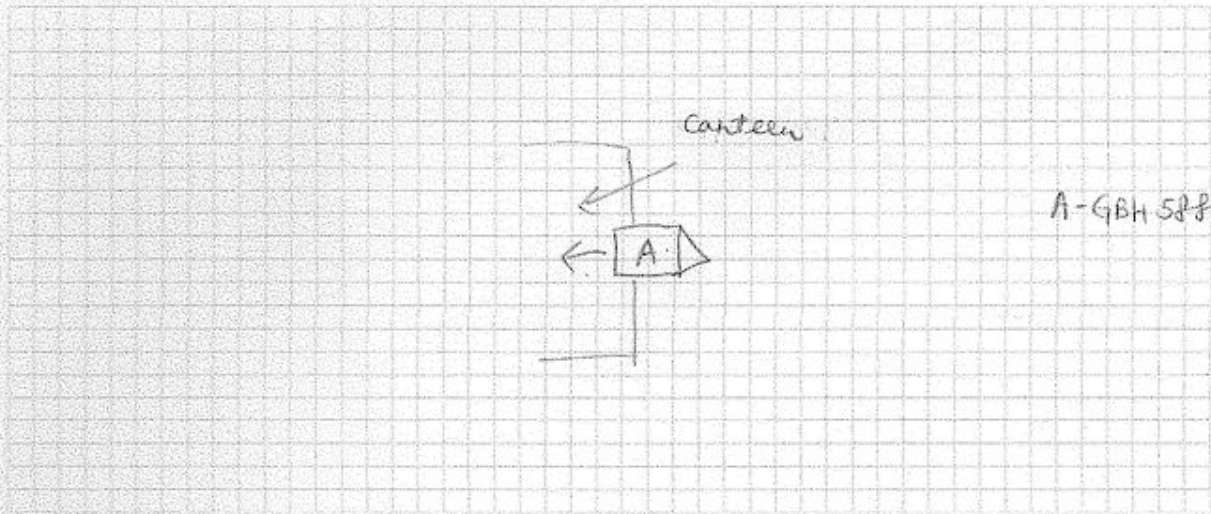

Brief Details.

On 12/03/2021 at about 1230hrs, I was driving my company van GBH5885P (V1) along Gul Street 3 open space carpark. I did a reverse parking to a parking lot.
