## ACCIDENT INVOLVING SMQ 1636R(AIG) AND SLD 1946B ON 10/02/2021

We refer to the above matter.

Third party reported that he was driving along Jalan Rindu. As there were cars parked along the road, he proceeded to overtake slowly on the opposite direction. Suddenly our insured vehicle veered out without caution and collided into the left portion of his car.

Our driver reported that she turned into Jalan Rindu road. Due to stationary cars blocking one lane of the road, she had to drive on the right lane(which was for the opposite direction). There was a car further down the road, our driver turned slightly to the left lane to give way to the car on the opposite direction but the car

had no intention to drive through. Before she could take out back to the right lane to continue driving, third party drover very fast on her right and grazed against the front of her car.

Both parties had no video footage for this matter.

We have spoken to our insured Mr Chan on this matter. He disagreed on liability as he said that his car has yet cross over the white line and was still within on the left lane road. Third party came from the right and grazed onto our insured vehicle. He had forwarded some scene photos(uploaded in Merimen) for our consideration. We are of the view that insured photo is inconclusive as she may have adjusted her car position after the accident.

In view of no concrete evidence to support either version, we suggest 50/50 on this matter.
