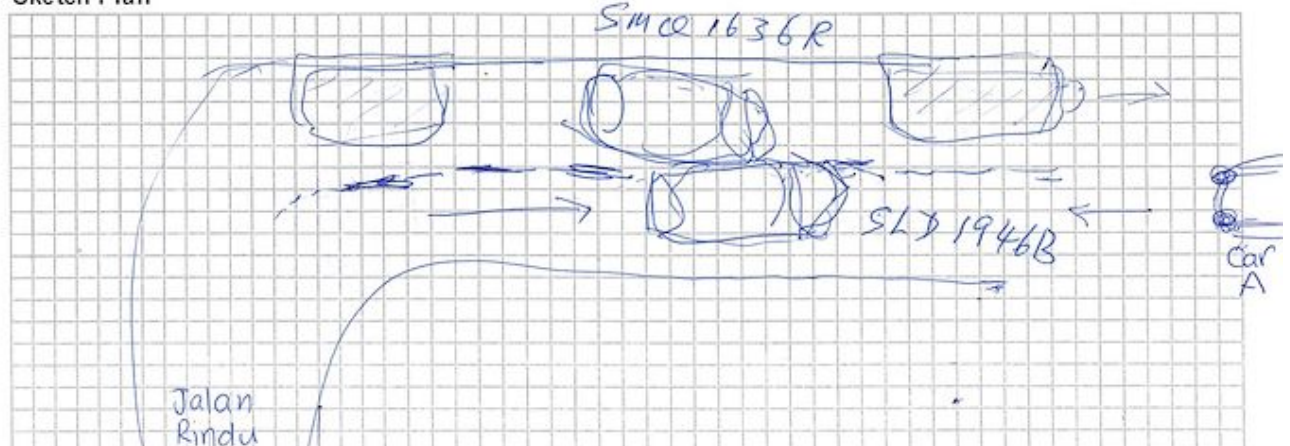

Describe Circumstances of the Accident


I turned into the Jalan Rindu road. Due to stationary cars blocking one lane of the road, I had to drive on the right lane (which was for the opposite direction). There was a car ~~car~~ (car A) further down the road, his headlights flashing at me. I ~~thought the~~ turned slightly to the left lane to give way to car A. But car A continued to flash his headlights, indicating that he had no intention to drive through. Before I could take out back onto the right lane to continue to drive, SLD1946B drove very quickly on my right and ~~car~~ grazed against the front of my car (SMQ1636R).

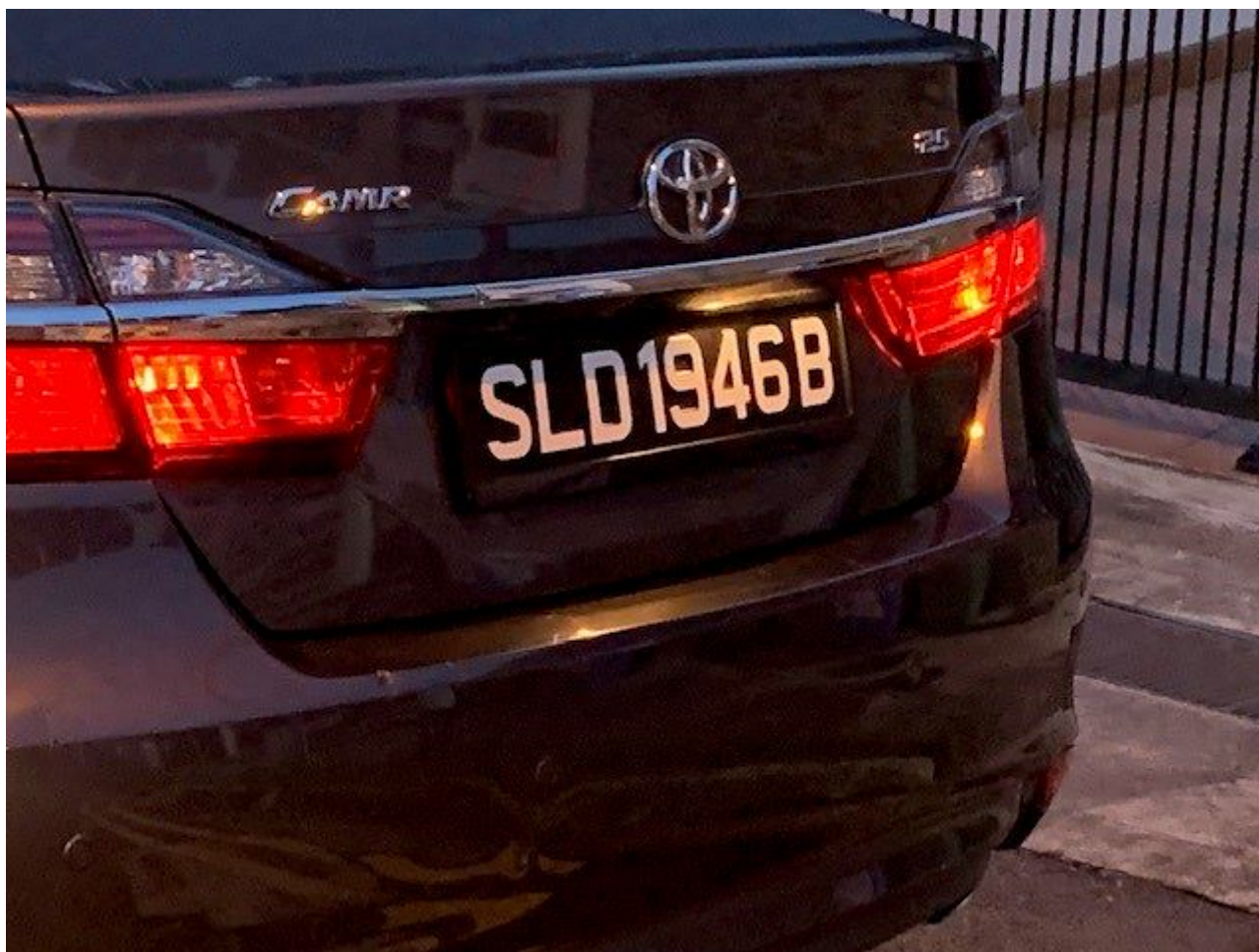
