Sketch Plan

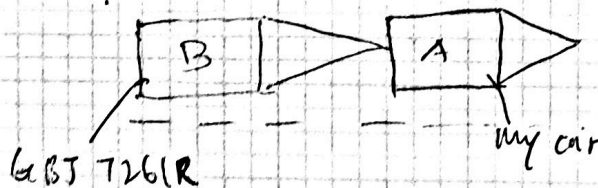


