We refer to the above matter.

We have reviewed and managed to obtain several accident scene photos from third party(see attached). The point of contact was at the rear right of third party vehicle. The damages of third party vehicle shown in the accident scene photograph appear to be fresh damage and consistent with the height of your vehicle front number plate.

We are of the view that we do not have a good defense towards the claim submitted by SMM9946P. We shall proceed to negotiate for an amicable settlement of the third-party claim at best to avoid further litigation, which would escalate to even more cost. Please be assured that we will do our due diligence to mitigate the cost.

Should you however wish to further discuss on the matter prior to our negotiations and settlement, please contact us within 07 days from the date of this letter.
