ACCIDENT INVOLVING SKJ 3251P AND SLD 8228U ALONG BALESTIER ROAD ON 13 MARCH 2018

We act for Tokio Marine Insurance Singapore Ltd ("our Clients"), the insurers of car no. SKJ 3251P and are instructed to represent Mr Phua Soo Teck @ Ng Chua Teck (hereinafter "Phua") the driver of the said car which was involved in an accident on 13 March 2018.

A. ACCIDENT ON 13 MARCH 2018

Car no. SKJ 3251P was reversing slowly within the carpark of Kwang Im Tng temple located at 525 Balestier Road and collided into the front of car no. SLD 8228U which was parked in a parking lot within the said temple.

With regard to the above, we enclose herewith copies of the following documents:

- a) Singapore Accident Statement lodged by Phua on 22 March 2018; and
- b) Singapore Accident Statement lodged by the owner of car no. SLD 8228U ("the Plaintiff") on 14 March 2018.

B. MC/MC 2914/2019

On 25 February 2019, the Plaintiff filed MC/MC 2914/2019 against Phua, claiming, amongst others, cost of repairs of car no. SLD 8228U at **\$8,500.00**.

In support of his claim, the Plaintiff has produced the following documents:

2018; and

b) Repair bill issued by Wahyu Automotive Body Work dated 29 March 2018.
