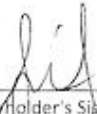

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At 1445hrs, my car started to move off from the traffic junction (upon green light) and I was in the second lane (from the left) when I entered the Newton Circus roundabout. As I was driving in the second lane (from the left), I heard a collision sound, coming from the left side of my car. I turned and saw a black Audi (SKF 7669M) on the first lane. I stopped for a while and realising it was dangerous to stop in the middle of the roundabout, I decided to drive forward, took a 12 o'clock exit from the roundabout and stopped at the side of the road (next to Newton Food Center). The driver of the black Audi (SKF 7669M) followed suit. Particulars were then exchanged between both parties.

You had been advised by workshop that in the event that you wish to claim against your own policy (OD claim), there is a **Fourteen (14) days clause** whereby the claim must be made within the stipulated timeframe from the day of occurrence.
