CIRCUMSTANCES OF ACCIDENT

ON 18/3/2021 @ 1450 HRS, I WAS DRIVING MY CAR BEARING REG NO SKF 7669 M IN THE LEFTMOST LANE OF NEWTON CIRCUS IN THE DIRECTION OF BUKIT TIMAH RD WHEN I SAW A WHITE COLORED CAR WHICH WAS THEN IN THE SECOND LANE FROM THE LEFT (AND ON OR STRADDLING THE LANE MARKING ON HIS RIGHT FOR THE SECOND AND THIRD LANES) START TO MOVE LEFT ACROSS HIS LANE AND TOWARDS MY LANE. GIVEN THE MOVEMENT OF HIS CAR TO THE LEFT, I REALISED THAT HE WAS GOING TO COME INTO MY LANE AND IMMEDIATELY INSTINCTIVELY BRAKED AND STEERED LEFT TO TRY AND AVOID A COLLISION. HOWEVER, AS I WAS ALREADY ON THE LEFT IN THE LEFTMOST LANE, THIS CAUSED ME TO HIT THE LEFT WHEEL OF MY CAR ON THE CURB. JUST THEN, THE WHITE CAR ENCROACHED INTO MY LANE AND CAUSED AN IMPACT ON THE FRONT RIGHT SIDE PORTION OF MY CAR WITH THE FRONT LEFT SIDE PORTION OF HIS CAR. AFTER HITTING MY CAR, HE STEERED BACK TO THE RIGHT AND CONTINUED GOING FORWARD WHILE MY CAR CAME TO A COMPLETE STOP. I RESUMED DRIVING AND FOLLOWED HIM WHEN HE EXITED NEWTON CIRCUS AT CLEMENCEAU AVE N, WHERE WE STOPPED AND EXCHANGED PARTICULARS.

MY FRONT VIDEO SHOWS HIM IN THE MIDDLE OF HIS LANE BEFORE THE COLLISION AND ON THE LEFT OF HIS LANE AFTER THE COLLISION. HIS LEFT FRONT WHEEL ALSO TURNS TO THE RIGHT AFTER THE COLLISION.
