Brief Details.

On 23/03/2021 at about 1200hrs, I was riding my motorcycle, a Yellow Yamaha - FBM5087A along Punggol East. I made a left turn intending to turn into Punggol Central. I rode over the Zebra crossing markings of the crossing and stopped, because there were oncoming traffic.

On the same day, a vehicle rear-ended me and I fell onto the road. Subsequently, the driver went out of his vehicle and helped me out. Firstly, we pushed my motorcycle to the side road. His vehicle details were, Silver Honda - SLU5300Z. He did not have any passenger and was not injured. I was injured and felt pain around my left knees, right leg and arms. I suffered scratches and tenderness around the areas. The driver offered to drive me to Punggol Polyclinic and I agreed. The damages on my motorcycle are as follows:

- 1) Bent plate number
- 2) Damaged tail light
- 3) Damaged back fender - bent inwards towards back wheel of the motorcycle
