ACCIDENT INVOLVING SKG 91U(AIG) AND SMU 7315G AT/ALONG MANDARIN ORIENTAL HOTEL EXITING LOBBY TOWARDS RAFFLES AVENUE ON 24/03/2021

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from SMU7315G against your insurance policy.

Based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by SMU7315U. Attached here with a copy of SMU7315G's car video footage for your easy reference. From the video footage, it shows that your vehicle was coming out from minor road(with stop line) and collided onto third party who was driving along the main road. Under Motor Accident Guide, vehicle turning out from a minor road should stop at a "stop" line to give way to traffic on the main road. Therefore, we are of the view that liability is not in your favour. We shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.

Should you however wish to further discuss on the matter prior to our negotiations and settlement, please contact us within 07 days from the date of this letter.

Please note that your No-Claim Discount (NCD) (if any) will be affected upon next renewal due to this Third-Party claim. However, if your policy has a NCD protector feature, it will be deemed utilized for this claim and your NCD will be protected.
