We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from SMU7315G against your insurance policy.

Based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by SMU7315U. Attached here with a copy of SMU7315G's car video footage for your easy reference. From the video footage, it shows that your vehicle was coming out from minor road(with stop line) and collided onto third party who was driving along the main road. Under Motor Accident Guide, vehicle turning out from a minor road should stop at a "stop" line to give way to traffic on the main road.
