Dear Mr Margrib Sha,

We have reviewed the matter and we are of the view that we do not have a good defense towards third party claim against your policy. As there is no video footage to show exactly how the accident happened, we are only able to review the case based on both parties reports as well as the damage photographs. Based on both parties report, we can agree on the followings: -

- 1. Your vehicle was coming out from parking lot.
- 2. Third party was on main driveway.

As for damages to both vehicles, if based on your statement, damage to third party vehicle should have been more on frontal portion instead of focus on left front corner. Therefore, it is hard for us to defense the case. Under Motor Accident Guide, any vehicle when moving out of parking lot should give way to vehicles approaching along the driveway. Generally, third party on the driveway has the right of way but should keep a lookout for vehicles moving out of parking lots, however that only contribute to 10%-20% of the liability (under the Motor Accident Guideline). Whereas the bulk liability falls onto the party who was moving out of a parking lot.

In view of the above, we shall proceed to negotiate for an amicable settlement of the third-party claim at best to avoid further litigation, which would escalate to even more cost. Please be assured that we will do our due diligence to mitigate the cost.

Spoken to OI, Mr Margrib Sha. Confirm accident. He disagreed that he is 100% at fault. According to him, he saw TP stopped and prepared to reverse park in the parking lot on his right(few lots away), he came out from his lot while third party suddenly moved forward as resulted the accident. OI said that after the accident, TP driver told him that he moved fwd as there is a pillar block his way on reversing. Advised OI that it is hard to defense if no video footage. OI understand that not possible to reject. But he think that it is not fair to him if he is 100% at fault. He only agreed 50/50. He also said that he had submitted all his scene photos to AIG for review. OI hope AIG can fight at least 50/50. Not 100% against him.
