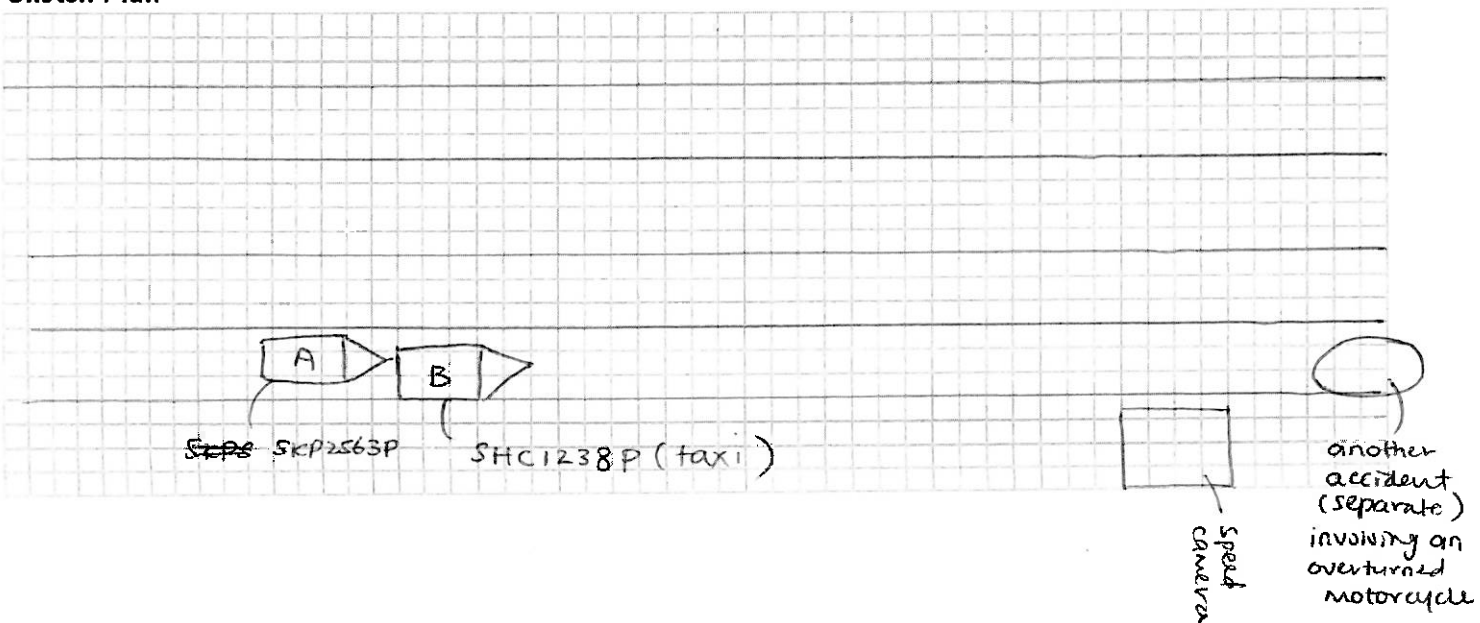

### Describe Circumstances of the Accident

On 24 March 2021, at around 1735hrs, I was driving along AYE towards Tuas, approaching Clementi Road exit, at the first lane of the expressway. I was driving at the prescribed speed limit under 90km/h. In front of my car was a blue-coloured taxi SHC 1238P. On other lanes 2, 3, 4, there were heavy traffic.

As the taxi came to an abrupt stop, possibly due to the fact that an accident occurred at some distance in front of his vehicle (after the speed camera). At that material time, I think that there was also another vehicle in front of the taxi which came to a stop. I stepped on my brake hard but was unable to stop in time. I pressed on my horn, which sounded for almost a second, before my car collided into the rear of the taxi (SHC 1238P). At that time, the road surface was wet as the rain had just stopped. I switched on my hazard light and exited the car to check on the taxi in front.


Both of us were not injured and we exchanged particulars.


Damages to taxi SHC 1238P - Dented right rear corner of the bumper and a dislodged metal plate close to the exhaust pipe.


Damages to my vehicle SP2563P - severely dented engine cover, damaged LED front light (left), cracked screen on headlight (left), front metal frame broken, interior engine component damaged, air con filter damaged. car plate missing (front)
