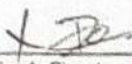

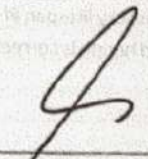
SKETCH PLAN

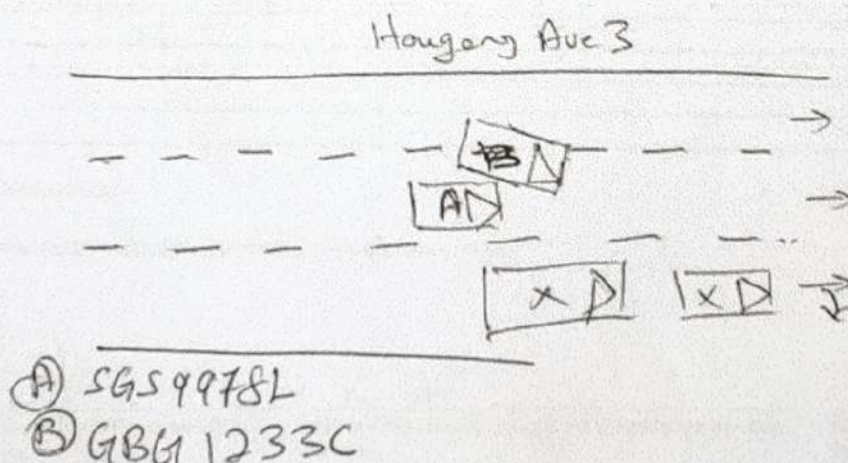

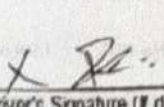
Describe Circumstances of the Accident

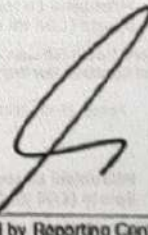
