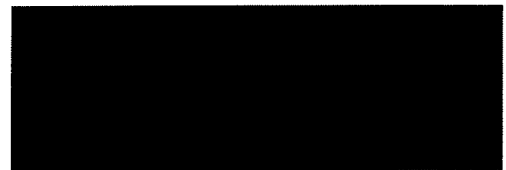

Brief Details.

On the above mentioned date and time, I was riding along Jurong West St 64 on the left lane. I was riding parallel to a taxi SHC7238A when he suddenly filtered into my lane, causing me to lose balance and fall with my bike. Subsequently, I was treated by paramedics and conveyed by ambulance to Ng Teng Fong General Hospital and was given 5 days Medical Leave from 11/02/2021 to 15/02/2021. I suffered dislocation on my left wrist, abrasion on my right forearm and abrasion on my lower right abdomen.
