

Describe Circumstances of the Accident

On the 28th March 2021, at around 8.30pm, I drove my car into the carpark at Queen Street openspace (Opposite Bugis +) wanting to have a dinner at Bugis +. It was quite a dim-lighted carpark but I was still able to manoeuvre within the carpark if I drove slowly. I stopped my car at the side while waiting for available carpark lots. Then I saw a car was about to move off directly behind me. I started reversing when the car left the scene. While slowly reversing, my car's side (left) scratched the car in the carpark lot at my left. I slowly drove to the front and did a check on the other party's car soon after. I noticed a light scratch on his car and then left a note to him before I left. We decided it was best to settle via insurance claim. The car I scratched was a full black car and was big and protruding compared to normal car. I strongly think that I was reversing ~~on~~ straightly but because his car was ~~big~~ ~~black~~ and may have protruded out of the normal parking lot, that the minor scratch occurred.
