Vehicle No SCY 21 Y TOYOTA CAMRY 2.0 accident report on 27 March 2021 Saturday at 16:28 pm

I was driving SCY21 Y (Black) from Farrer Road turning left onto Holland Road. I stopped at the zebra crossing and it was also the Farrer Road/Holland Road junction where cars were travelling along Holland Road towards the city. After that I gradually drove along Holland Road. Suddenly a car (Dark Silver Honda SMR 2836T) in front of mine braked. It was so sudden that I could not manage to stop my car in time and hit onto it. Both car drivers stepped out of our cars to check.

The other driver Mr Lim Hung Teng S8724922J proceeded to check his car. He was driving an Uber/Grab licensed car and I realised he could have suddenly stopped because I saw his client/passenger; a lady and little girl walked towards us from our left behind to speak to him. I then understood that most likely he drove past and overshot his pickup of his clients and may have seen his clients and thus stopped suddenly.

As a guide for the exact location of the accident; it was between the Farrer Road/ Holland Road junction and a bus stop along Holland Road, hence I would not have anticipated a vehicle suddenly stopped right in front of me. He may probably saw his client and stopped to pick them up at the Holland Road roadside.

We did not want to block the oncoming traffic and decided to shift our cars down the road onto Somerville Estate Road to talk and take pictures.


