Dear Mr Chew and Li Li

I refer to your email below.

I have reviewed the video and photos taken by our surveyor at the time of his inspection. I note a cut on the right side of claimant's front bumper. The pattern of the cut suggest that it was caused by a sharp horizontal object, likely to be the circled area of the insured lorry shown in the photo below.



The cut on the front bumper of claimant's vehicle had extended to the front right headlamp. See photo below.



The video had showed the insured lorry moving out of the parking lot and in the midst of turning out, the insured lorry shook before the driver reversed and steered wider, thereafter completing its moving off. The contents of the video appears to indicate that there was contact. The damage pattern on the claimant's vehicle is consistent to the events seen in the video.

We have checked with several local stocklist on the price of the front right headlamp. The price range was \$10,779.00 to \$11,924.05. The insured vehicle has been sent to the local agent for repairs. The cost of repair, compared to normal workshops, will be higher.

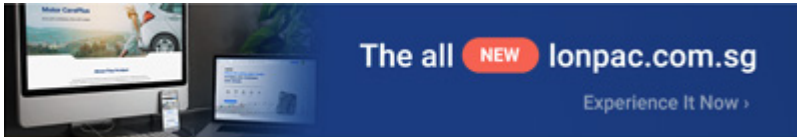
