THIS ACCIDENT HAPPENED AROUND 1025HRS OF 31/3/21 @ THE SLIP ROAD JUNCTION OF PASIR RIS DR 1 & LOYANG AVE.



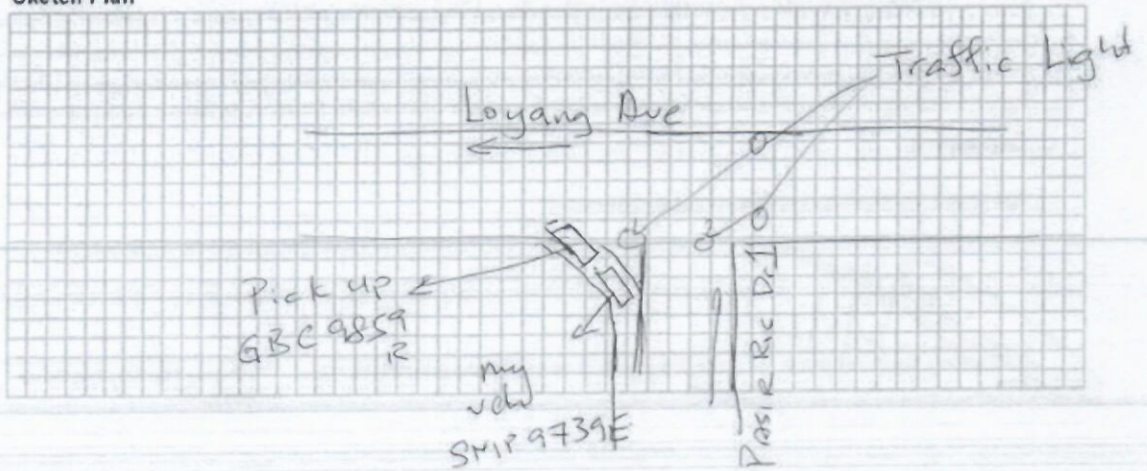
