# Brief Details.

On or around 5pm on 31st of Mar 2021, my foreman Mr Ismail (Fin No.: G8237589P) was working in 15E Lyndhurst Road. He was approached by Mr Jama and Mr Michael. (Mr Jama is the driver who drove the car on the alleged accident. Mr Michael told Mr Ismail that he is the boss of Mr Jama). When they approached him, they told Mr Ismail that around 3:40pm yesterday (30 Mar 2021), Mr Ismail's lorry has collided into his car around Goodman Road. Mr Ismail denied the allegation and told them that he is unaware of any accident happening. Mr Ismail further justified that there is no damages on his car and if he has ran into anything, he would have known because of the impact. Mr Michael then informed Mr Ismail to make a police report immediately. He has further warned Mr Ismail that if he did not, the police will catch him, his work permit will be revoked and he will be imprisoned or to be repatriated back to hometown. Mr Michael told Mr Ismail that he is helping him by informing him that he must report police immediately. Mr Ismail then called Miss Mei Sun (who is the employer) who then asked Mr Ismail to get more information from Mr Jama and Mr Michael. Mr Ismail managed to obtain part print of the "police report" and sent the images to Mei Sun via WhatsApp. The images were, 3 photos containing sections of what looks like a police report. Mr Ismail also passed Mr Michael Ms Mei Sun's contact number and informed them to contact her. Mr Michael further told Ismail that they have made a police report and the police has a video showing the accident and thus, Mr Ismail cannot run away. When Mr Ismail asked for their contact number, Mr Michael told Mr Ismail that he is the boss and he doesn't need to give Mr Ismail any number. Instead Mr Jama gave Mr Ismail his phone number. They then left the place. Mr Ismail then called Miss Mei Sun to contact Mr Jama who has given Mr Ismail his number. I then called Mr Jama around 5:47pm to understand the situation. Mr Jama explained that he has spoken to Mr Ismail about the accident. I then

requested for the report number and where the incident took place. Mr Jama informed me that the accident took place around the junction between Goodman and Crescent Road. I then informed Mr Jama that we will make the police report with Ismail. After I have put down the phone, I checked again with Mr Ismail. He confirmed that he did not know and was unaware of any accident or if his lorry has hit or collided into anything and especially on 30 Mar 2021. He further explained that if there were accident, the driver should have stopped him by honking or stopped his car immediately.
