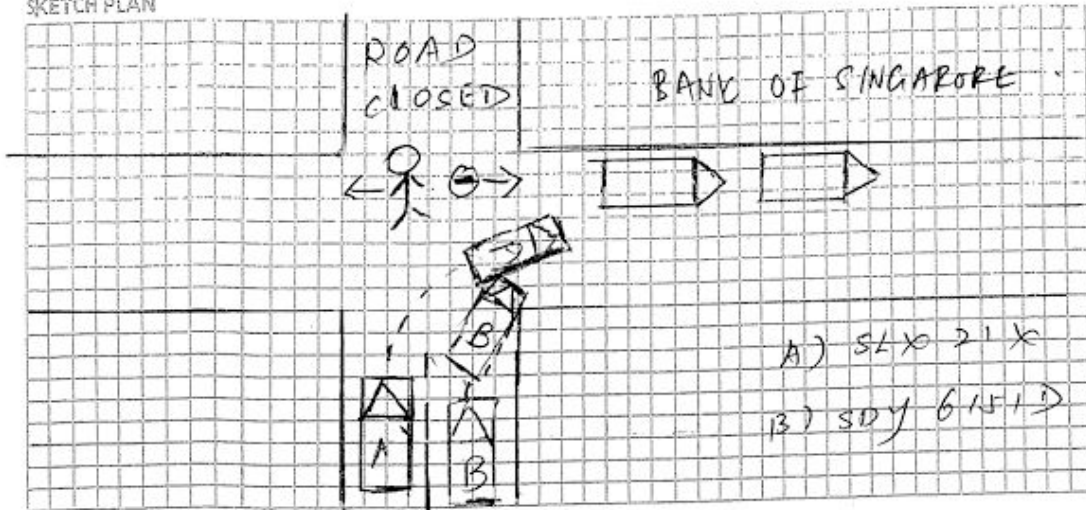

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


30 Mar'21 on the above date and time my vehicle (SLX 21X) was driving at Malacca St. Due to road closure and diversion by construction worker on market street, all vehicles were diverted to back lane of Bank of Singapore.

Both lanes diverted to back lane and two lanes merged into single lane. Heavy vehicles and other road blockages alongside back lane. At turning point, vehicle A (SLX 21X) had proceeded in front of vehicle B (SDY 6151 D) but vehicle B still proceeded onwards.

As a result, vehicle B hit onto rear right portion of my vehicle.
