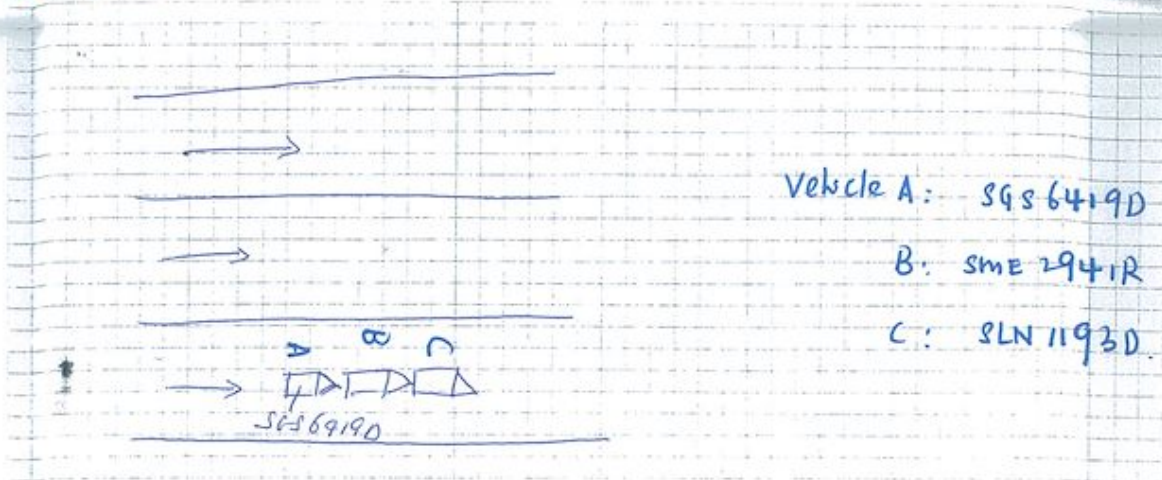

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 03/04/21 at about 1140h, I was driving along SLE towards Woodlands near to lamp post 291, when suddenly the car in front of me suddenly jammed brake. I was travelling around 90km/h but was not able to brake in time due to the sudden braking. The airbags were activated and hit onto me. When I got off my car, I then realised that it was a chain collision with other two vehicles in front. The driver of the car in front (black Nissan Teana) informed me that the car in front of him had suddenly jammed brake and he had hit onto his car. There was no car in front of that car. The first car owner, 2nd car owner and myself exchanged details and they drove off. My car was then towed away by EMAS Recovery. I would like to add that it was not raining and road is dry.

CONTINUATION OF REPORT**Brief Details.**

I was driving along SLE towards Woodlands and on the extreme right lane, at the speed of about 90km/h near lamp post 291. Traffic was moderate. Suddenly the car in front of me jammed brake and I also hit on my brakes. However, my car crashed into the rear of the car in front of me and the airbags were activated. When I got off my car, I then realised it was a chain collision. There were two cars in front of me. After speaking with the owner of the car in front of me (SME 2941R, Mr Chin) he informed that the car in front of him had suddenly jammed brakes without reason. There were no other cars in front of him. Upon asking the 1st car owner Mr Liang, he claimed that another car in front had jammed brake suddenly. However, there was no cars in front of him. Another accident was about 100 m away in front of us. After exchanging particulars, the two car owners drove off and EMAS recovery team towed my car away as its not drivable anymore. I went to the doctor as I had some cuts on my face, redness on my left arm and ache on my back and neck area. The doctor gave me a 4 days medical leave.
