However, his NCD will still be affected, since we cannot absolve him of all liability.

As for TP, please assist to get the video footage and scene photos. Otherwise 50/50 since both vehicle were moving from a stationary position and it seems that Taxi driver should have been aware of Insured vehicle changing lane.

Dear Jeremy

We refer to the above matter.

TP reported that he was at the traffic junction of Nicoll Highway and slowly proceed to move forward when his front vehicle start moving. OI then encroached into his lane and grazed his taxi.

OI reported that he was trying to filter to the right. The traffic light was red, he signal and prepare to filter once he got clearance. He slowly filter to the right lane and collided with TP's vehicle.

We have spoke to OI, he admitted that he was in the wrong to filter. However, he is not agreeable to bear 100% responsibility for the accident.

He was filtering very slowly into the lane, and the car was already $\frac{3}{4}$ in the lane. TP should have saw his car and slow down to avoid collision. According to our insured, TP driver was travelling in a very fast speed, thus not able to slow down when our insured was $\frac{3}{4}$ in the lane.

Based on OI's video, we could not determine if TP was travelling at fast speed.

We are of the view that liability is not in our insured's favour as TP was travelling in his own lane.
